The Commonwealth of Dominica has received financing from the World Bank toward the cost of the Caribbean Digital Transformation Project, and intends to apply part of the proceeds toward payments under the contract for Appointment of a System Integrator for Design, Development, Deployment, Operations and Maintenance of the Unique Identification (UID), Civil Registry (CR) and Vital Statistics (VS) System in Dominica.

The Ministry of Public Works, Public Utilities and the Digital Economy, Government of Commonwealth of Dominica now invites sealed Proposals from eligible Proposers for "Appointment of a System Integrator for Design, Development, Deployment, Operations and Maintenance of the UID, CR and VS System in Dominica".

The procurement process will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *Procurement Regulation is dated: July 2016, revised November 2017, August 2018, November 2020 and September 2023 ("Procurement Regulations")*, and is open to all eligible Proposers as defined in the Procurement Regulations.
